<u>IMPORTANT</u> – Before signing this Acceptance Form you should read the <u>terms and conditions</u> attached to this Acceptance Form.

 - (i) there are no court orders in place in respect of our child;
 - (ii) any information about us and/or our child that has previously been notified to the School (including information about our child's health / medical conditions, disability and special educational needs as part of the School's registration and admissions process) is and remains complete and accurate; and

(iii) our child has the right to enter, live and study in the United Kingdom and, if applicable, we have made appropriate arrangements for our child's visa application, travel, reception, living and care in the UK. If we require the School to sponsor our child and issue a Certificate of Acceptance of Studies (CAS) to our child so that they may apply for relevant permission to enter or stay in the UK as a student (for which the School may charge an administration fee), we have previously notified the School of this. Please note, if the School has made your child a conditional offer, then it will not be able to issue you with a CAS until the conditions of that offer have been met.

<u>IMPORTANT</u> – when you complete, sign and submit this Acceptance Form and pay the deposit, you and the School enter into a legally binding contract, upon the School's terms and conditions.

If you subsequently change your mind and decide to withdraw your child before he or she takes up their place, you may lose your deposit and be responsible for paying us fees in lieu of notice – see <u>Clause 3</u> of the terms and conditions for more information about this.
